Multivariate impacts of the COVID-19 crisis on women and girls living with or at high risk of HIV (W&GLHIV) in Nigeria: a rapid national and sub-national cross-sectional survey

Project background/rationale

The COVID-19 crisis causes profound consequences worldwide. The efforts to curb the spread of the virus are driving societies and economies in a turmoil. There will be aggravated impacts of COVID-19 crisis for women, increasingly so for those living on the economic margins. The pandemic is deepening pre-existing inequalities and discriminations, exposing vulnerabilities in social, political, and economic systems which are in turn amplifying the impacts of the pandemic. Although we have learned a remarkable amount about COVID-19 in a short time, its potential impact on women and girls living with HIV (W&GLHIV) in settings with high HIV burdens is becoming a major concern, increasingly so in dual colliding HIV and COVID epidemic settings. *We sought to assess* (i) multivariate impacts of the COVID-19 crisis on W&GLHIV in Nigeria provincially and nationally, and (ii) the role and resilience of the community response in addressing HIV and public health gaps in mitigating the impact of the COVID-9 crisis.

Objectives of the project

The study will address the following objectives:

- To determine the impacts of the COVID-19 crisis in terms of increased inequalities and socioeconomic vulnerabilities among W&GLHIV in Nigeria.
- To determine the sociodemographic, economic, and clinical factors associated with the reduced access to health services, including HIV prevention and treatment services, sexual and reproductive health (SRH), family planning (FP), TB prevention and treatment services among W&GLHIV during the COVID-19 crisis in Nigeria.
- To provide gender-specific considerations related to vaccination for SARS-CoV2 among W&GLHIV, including W&GLHIV in key and vulnerable populations in Nigeria.
- To provide insights to gender-specific strategies and policies designed to reduce the impacts of the pandemic on W&GLHIV in Nigeria.

The purpose of the project is to learn about the implications of COVID-19 crisis for W&GLHIV, including for those in key and vulnerable populations (KVPs), in settings with high HIV burdens, to get insights on how to rebuild and reshape the HIV response once the wave of COVID-19 is passed and nations learn to live with the dual pandemic of HIV and COVID-19.

Duration of project

On countersignature of the contract until 30 September 2021.

Site(s) of proposed Project

Nigeria is Africa's largest economy and most populous country, with more than 200 million inhabitants. The country suffers from high rate of poverty and income inequality, with 50% of the population living in extreme poverty and 70% do not have access to safe drinking water. In addition, 69% of urban residents living in slum conditions and 23% of labor force is unemployed. The country is divided in 37 states grouped in 6 geopolitical zones. States vary immensely in religion, culture and language, human development, and income.

Nigeria is also a home to one of the largest HIV epidemics in the world, with estimated 1.8 million HIV cases cumulatively, and estimated 45 thousand deaths due to AIDS. In Nigeria, women bear a

disproportionate burden of the disease, with estimated 940 thousand HIV cases. The HIV epidemic is feminized with a gender ratio of 1.3:1. Nigeria is otherwise the fifth most hit African country by COVID-19. From the start of the pandemic, there have been about 160 thousand cases of COVID-19 diagnosed in Nigeria, and about 2 thousand deaths due to COVID-19.

There are six geopolitical zones in Nigeria. The team intends to recruit participants in each of the geopolitical zones to estimate multivariate impacts of the COVID-19 crisis on W&GLHIV in Nigeria. The rationale for the selection of the geopolitical zones is that they represent a diverse segment of the Nigerian population. The states will be decided in consultation with the national community leaders.

Major beneficiaries

The study aims to recruit an estimated minimum sample size of 2,160 participants. This sample size is required to provide an adequate variability and diversity in the survey questions. Whilst this is not a probability-based sampling, the sample of participants (N=2,160) also satisfies the sample size statistical criteria with a 95% confidence level and 5% margin of error.

The target population is W&GLHIV aged 15-64 years old, as well as W&GLHIV in KVPs, including those living with disabilities, involved in transactional sex, sex workers or female sex workers (FSW), migrants, refugees, W&GLHIV who use and/or inject drugs, and W&GLHIV of the LGBT+ community.

The inclusion criteria for the study participants include the following:

- Must identify as W&GLHIV, including W&GLHIV in KVPs (e.g., transgender woman living with HIV, etc.)
- Must be aged 15 years and older.
- Must give informed consent.
- Must not have already participated in this same survey.

Implementing agency

The Institute of Public Health (IPH), Obafemi Awolowo University, Ile-Ife, Nigeria was established in 1994 to serve as a centre for generating ideas about health development, health promotion, and disease prevention programs, in line with national health policy and priorities. Inaugurated as a research, training, and service organ of the College of Health Sciences, Obafemi Awolowo University, IPH is the only university-based Institute of Public Health in any Nigerian university today and is a part of the College of Health Sciences at the OAU, Ile-Ife. The Institute has conducted numerous large-scale multi-state household surveys within Nigeria and has a large network of enumerators and other experts.

Responsible officer(s)

The Principal Investigator (PI) of the study in Nigeria is Dr Morenike Oluwatoyin Ukpong, Professor at the Institute of Public Health of the Obafemi Awolowo University, Ile-Ife (Nigeria).

Scope of work

Ethics review: The Principal Investigator in Nigeria will request the ethics clearance from the Institutional Review Board (IRB) of Obafemi Awolowo University, Ile-Ife.

Implementation: Upon ethics review, as a first part of the study, consenting participants will be asked or will be assisted to fill out a confidential anonymous web-based questionnaire (**Questionnaire #1**). As a second part of the study, the prominent formal and informal community-based organisations, which provide services and/or assistance to W&GLHIV, and W&GLHIV in KVPs, in the six geopolitical zones in Nigeria will be identified and offered to complete a web-based questionnaire designed to assess the known impacts of the COVID-19 crisis on W&GLHIV, and the role of the community response (**Questionnaire #2**). The second questionnaire is aimed at the community organizations, including CSOs, CBOs, NGOs, formal and informal, working with any of the target population subgroups. The most prominent community organizations will be identified in all provinces and at the national level and invited to take the survey. Questionnaires will be filled via phone/tablet/computerassisted self-interviewing (CASI). In the case where the participant has literacy issues, the interviewer will offer computer-assisted personal interviewing (CAPI).

Promotion and data collection: An outreach strategy will be employed to rollout and promote the survey among the target subpopulations. Key CBOs will be identified and invited as partners to rollout and promote the survey among the W&GLHIV. Data collectors will come from participating CBOs and may include representatives from the community of W&GLHIV, including W&GLHIV from KVPs. This will allow meaningful inclusion and capacity development. Training of data collectors will be conducted ahead of any data collection activities. Data collectors will be linked to the identified community leads to start the dialogue and plan the targeted community outreach and data collection activities. The overall study manager will supervise data collectors for the duration of the project. The assigned study manager will coordinate data collection efforts, organize logistical support to the data collectors, identify and engage representatives of the CSOs, CBOs, NGOs, and other formal/informal networks, which are involved in providing support to the study's target subpopulations. In addition, the research team will ensure that the sample has national and sub-national representation, socio-economic diversity, and will adjust the work of the data collectors/interviewers accordingly to ensure representation across target subpopulations.

Survey content: The first questionnaire (**Questionnaire #1**) is designed as a population based individual survey, which comprises approximately 65 questions, combining validated instruments with specific questions related to COVID-19 crisis. **Among others, it includes modules on the impact of the COVID-19 crisis, such as:**

- Sociodemographic questions, e.g., residence, age, education, etc.
- Health care access and its change due to COVID-19 crisis: COVID-19, HIV, tuberculosis (TB), FP, SRH.
- Happiness, wellbeing, and mental health, and change of the above due to COVID-19 crisis.
- Any change due to COVID-19 crisis in the following areas: sexual and gender-based violence (SGBV), intimate partner violence (IPV), unwanted pregnancies, deliveries of babies at home.
- Any change due to COVID-19 crisis in the following areas: economic vulnerability, poverty, change in income, job, change in socioeconomic status.
- Any change due to COVID-19 crisis in the following areas: behavioural economics variables such as time preference, risk aversion, altruism.
- Any change due to COVID-19 crisis in the following areas: access to social protection measures, COVID-19 special programmes.
- 'Logic' questions related to the impact of COVID-19 measures and change of attitude faced by each population cluster such as living with disabilities, being migrant or refugee, engaging in sex work or transactional sex.

The second questionnaire (**Questionnaire #2**) is intended to additionally survey identified prominent non-governmental organizations (NGOs), civil society organizations (CSO), community-based organizations (CBO), and other formal and informal networks engaged in supporting the target group,

W&GLHIV, including W&GLHIV in key and vulnerable populations. This part of the study is aimed to assess the known impacts of the COVID-19 crisis on W&GLHIV, and the role of the community response. It will reflect the experiences, and contributions of the community stepping in to ensure access to HIV and other essential health care during the COVID-19 crisis. The questionnaire will likewise assess resilience, the change in their capacity to reach out to their members, as well as to support those disproportionately affected by the COVID-19 crisis, and the challenges they face in the aftermath of the COVID-19 epidemic.

The Questionnaire #2 will cover among others the following topics:

- The role in addressing public health gaps and health care disruptions.
- Integrating prevention efforts and services to respond to GBV.
- Expanding the capacity of shelters for victims of violence, designating domestic violence and GBV shelters.
- Expanding access to sufficient and affordable water, sanitation, and hygiene services for vulnerable groups of W&GLHIV (including in informal settlements, rural areas, and refugee camps).
- Expanding the reach and benefit levels of social assistance programmes, work-sharing, childcare services.
- Expanding feeding programmes.
- Introducing new cash transfers, vouchers, social pensions, expanding access to paid family leave and paid sick leave.
- Sustaining and expanding access to HIV, SRH, FP, TB, and other essential healthcare programmes.
- Building a gender-inclusive socio-economic response and recovery for impacted W&GLHIV, including from the KVPs.
- Stepping up advocacy and awareness campaigns.
- Change in funding for the community response.

Data Analysis: Data cleaning and statistical analysis will be performed in Q2-Q3 2021 to describe and interpret the findings of the survey. A report on the results and findings is intended to be published in Q3 2021 following data collection and statistical analysis.

Security and data privacy

The study does not collect any personal information and records are unidentifiable. The questions, taken all together, do not reveal any information that could make respondents vulnerable to harm or to risk of exploitation. The questionnaire does not use or collect geolocation data, it does not install any tracker cookies on the device of the respondents.

Participants access the questionnaire through an SSL end-to-end encrypted, secured link. Responses are anonymous and no personal identifier is collected. Each member of the survey team will sign a declaration of confidentiality and privacy.

Individual responses are stored on the server of the survey tool (stored in Europe, GDPR compliant). Security backups are regularly done (UNAIDS/SID) and securely stored on an encrypted cloud (pCloud, with encrypted cloud located in Europe)

These primary data collection efforts in a rapid assessment will provide necessary insight for any policy shift and advocacy necessary for the HIV response in high HIV prevalence settings, where the two epidemics HIV and COVID-19, are colliding.

Involvement of UNAIDS envisaged

UNAIDS SID focal points will support the Institute of Public Health of the Obafemi Awolowo university, Ile Ife in the development of the survey design and the outputs as described in the table above, including development of the research protocol, data collection tools. UNAIDS will advise and provide on oversight to data collection, will support data analysis, and development of the report of the findings.

<u>Monitoring</u>

UNAIDS will hold weekly online meetings, and correspondence necessary during all stages of the project implementation, including appraisal for the design phase, finalization of the research proposal, and data collection tools, as well as later will conduct monitoring for the implementation phase, including study roll-out, data collection, training, recruitment of the participants, monitoring of the response rates, and will furthermore perform any necessary adjustments to fulfil the project objectives, and outputs.

UNAIDS will oversee the project implemented by the Institute of Public Health, Obafemi Awolowo University, Ile Ife with particular attention regarding the following activities:

- Develop an operational plan for the project, including detailed activities and timelines, frequency and schedule of data collection, responsibilities for the project implementation.
- Once the operational plan is elaborated, a monitoring plan will be prepared. It will address
 the expected results level, i.e., when, whether or to what extent expected results are
 being achieved.
- Improve the implementation of the project and ensure the optimum use of funds.
- Review the workplans and budgets.
- Recommend adjustments and corrective action, if necessary.
- Foster accountability and transparency in the management process.
- Ensure that the technical cooperation is pertinent, effective, and efficient.
- Provide well substantiated information on project progress and results.

- Learn lessons of experience with the aim of improving the design, formulation, and management of project.

<u>Evaluation</u>

Evaluation will be performed during the project implementation to examine whether the study is successfully recruiting and retaining its intended participants from the defined target groups, using training materials and following the research protocol and ethics, that meet standards for accuracy and clarity, maintaining its projected timelines, coordinating efficiently. Evaluation during the project implementation will be used to inform mid-course corrections to study implementation (formative evaluation) and to shed light on implementation processes (process evaluation). Following completion of the project, evaluation will examine its outcomes, summarize its overall performance, including, its efficiency and sustainability.

Sustainability / replicability

With all eyes are on health, health systems and health care, with countries wanting to be better equipped to deal not only with COVID-19 but also to create healthier, more resilient societies, this project intends to build the new insights on the multivariate impacts of the COVID-19 crisis on women and girls living with HIV in Nigeria. The context of two colliding epidemics, experiences of individuals and communities collected in a consistent manner will reveal the knowledge necessary to shape the future HIV response and potentially have an impact on the community health. This opportunity can be seized by learning from HIV and from COVID-19 to make important changes to develop rights-based, equitable, people-centred systems for health. The project findings can be expanded within the African region and potentially adapted in low- and middle-income settings and similar epidemiological contexts.
